## Procedures and Requirements for All Vendors

Set up will begin at 9:00 a.m. All vendors must be set up no later than 11:30 a.m. and all vehicles must be removed from grass areas, parking will be allowed only in designated areas.

### Food Vendors

1. All Food Vendors must meet local and state health department requirements. Food Vendors must submit permits and insurance documents along with the vendor application.
2. All Food Vendors using oil and other solid or liquid substance must have containers for used substances. No oil or other substance will be disposed of in sewer drains or on park grounds.
3. All Food Vendors must post if their food or other consumables contain peanut oil or peanut substances.

### Merchandise Vendors

1. Please enclose photographs (if you have any available) of the items you wish to sell at the festival. We ask you to provide the photographs to enable us to assess the best fit between your product and the setting we are creating for the festival. We cannot accept responsibility for samples so please only send photographs (electronic or printed). We will keep the photographs on file for future festivals, and none of the photographs will be returned to you.
2. The Committee reserves the right to ask for ANY item to be removed from a vendor's booth. For this reason, please make sure to let the vendor coordinator know of any changes to your inventory before the Festival start date.
3. Merchandise Vendors who sell music will not be allowed to play their music at a volume that disturbs festival events or other vendors. Music Vendors may play samples of their music and movies for a customer. Any music or movies that contains sexually explicit lyrics, profanity, nudity or violence, will not be tolerated. Vendors violating this rule will be evicted immediately without a refund.
4. Any merchandise with language and symbols of drugs, nudity, sexual activity, weapons, or violence cannot be sold at this event.

### Items that cannot be consumed served or sold at the Concord-Cabarrus Juneteenth Festival.

1. Any item with any part of the name Concord-Cabarrus Juneteenth Festival.
2. Any item with Juneteenth graphics.
3. No alcohol can be consumed, sold or served at the Festival.

### Animals

1.No animals can be displayed or sold. Due to public safety, vendors are not allowed to have animals in vending areas. Service animals are allowed.

Any Vendors who violate any of the above will be asked to leave and will not be admitted to future Concord-Cabarrus Juneteenth Festivals, and events sponsored by Concord-Cabarrus Juneteenth Celebration Committee.

I have read the above list and will comply with the procedures and rules set forth by the Concord-Cabarrus Juneteenth Celebration Committee. I further understand that if I found in violation of any of the above, I will be asked to leave from the Festival and will not be entitled to a refund of my vendor fees. I further understand that I am solely responsible for the sell, use of my products and services, and will indemnify the Concord-Cabarrus Juneteenth Celebration Committee and any of its associates against responsibility for any legal procedures as it relates to my products and services.
